TO ALL TOURISM ENTERPRISES (HOTELS, LODGES, GUESTHOUSES, CAMPS, NIGHT CLUBS, TRAVEL AGENCIES, TOUR OPERATORS, RESTAURANTS, CAR HIRE, CONFERENCE FACILITIES CASINOS ETC)

Notice is hereby given to all tourism enterprise operators that the renewal of the tourism enterprise licences has commenced and the deadline for receiving applications **FOR 2015 is 21st November, 2014**. Operators who did not renew their licenses in previous years will be required to pay amounts due, plus penalties as stipulated in Section 80 under the Tourism and Hospitality Act of 2007.

Any tourism enterprise that will be found operating without a tourism enterprise licence starting 1st January, 2015 will be considered an illegal establishment and the operators shall be prosecuted under Subsection (6) of Section 71 of the Tourism and Hospitality Act N0. 23 of 2007.

All operators are requested to comply with this notice to avoid inconveniences.

Please note that some tourism enterprise operators have not collected their 2014 licences. Those involved are requested to collect them as a matter of urgency. Any tourism enterprise that fails to display the current license in its premises contravenes section 33 (1) of the Tourism and Hospitality Act number 23 of 2007.
